



Board Membership Requirements, Definitions & Procedures

For Primary/Secondary Board Membership as well as MLS Services

NOTE: As per our Bylaws, if you have joined an office that is already a member of our Board and/or MLS you, as an agent of that office, are in turn required to join the Board and/or the MLS upon your license being issued.

- ✓ must hold a current, valid Wyoming Real Estate Broker's license or Appraisers license, are sole proprietors, partners or corporate officers or branch office managers,
 - ✓ are engaged actively in the real estate profession, including buying, selling, exchanging, renting or leasing, managing, appraising for others for compensation, counseling, building, developing, or subdividing real estate,
 - ✓ and who maintain or are associated with an established real estate or appraisal office in the State of Wyoming or a State contiguous thereto,
 - ✓ and who shall be responsible for all duties and obligations of Membership including the obligation to arbitrate pursuant to Article 17 of the Code of Ethics and the payment of Board dues.

- ✓ Individuals who hold a current, valid Wyoming Real Estate Salesmen license or certified appraiser who engaged in the real estate profession other than sole proprietors or corporate officers, or as individuals in positions of management control (in other words anyone who is NOT the Designated Participant such as agents, licensed assistants, appraiser trainees and additional appraisers in the same office)
 - ✓ and are associated with a Designated REALTOR® Member already established with NEWRA.
 - ✓ and meet the qualifications set out in Article V of the Bylaws.

The Multiple Listing Service and SentiLock System are SERVICES of the NE Wyoming REALTOR Alliance. These services are only available to REALTOR Members who have a current, valid Wyoming Real Estate Brokers/Salesman license.

- _____ Must be a primary member of a Board of REALTORS in the state of Wyoming or contiguous state.
- _____ Must hold primary MLS membership in a Board of REALTORS in the state of Wyoming or a contiguous state.
- _____ As per the NEWRA Bylaws and MLS Rules & Regulations, all members holding a Wyoming license under the Designated Broker to sell in the state of Wyoming are required to participate in the MLS.

Additional documentation required for Secondary Members Only:

- A letter of good standing from your primary REALTOR® Association and their MLS and any other Boards/MLS's in which you are affiliated.
- A copy of your real estate license or appraiser certification from all states where licensing is active. Must be licensed/certified in Wyoming to receive services.
- MLS Participation Agreement, MLS Membership Application.
- Payment for all applicable fees (see price sheet). We accept checks, debit and credit cards.

MLS Participation Agreement

I, _____ Designated REALTOR®/Broker Salesman (Participant)

from the real estate firm of _____, (Firm) request participation in the Northeast Wyoming REALTOR® Alliance - Multiple Listing Service.

In requesting participation, I understand that both the Firm and the Designated REALTOR®/ Broker will be responsible for all fees assessed to Participant, and any user fees which are due and payable for individual services rendered. I understand, the Designated REALTOR®/ Broker, is responsible for all licensees in the office and the licensees that access the MLS system through participation. It is also understood that The Firm is jointly and severally liable for all service fees incurred by the Firm and/or by said licensees.

Participant and Firm agree to indemnify and hold the MLS harmless from all claims and liability relating to Participant and Firm's use of the MLS system and services.

As a Participant, I agree to abide by the NAR Code of Ethics, NEWRA Bylaws and MLS Rules & Regulations. Additionally, I understand that the information obtained from MLS is confidential proprietary market information which is available only to Participants of the MLS. I agree that I will only provide access to or information from the MLS in accordance with the NEWRA Bylaws and MLS Rules & Regulations. Violation of this provision is a violation of the NEWRA Bylaws and MLS Rules & Regulations and is subject to a fine or any other sanction provided for in the NEWRA Bylaws and MLS Rules & Regulations.

All data and photos submitted to the MLS becomes the property of the Northeast Wyoming REALTOR® Alliance - Multiple Listing Service. However, this does not restrict a Participants ability to use the data. Further, Participant acknowledges that all data available to Participant through the MLS service and system is provided "as is" and neither MLS nor its data supplier makes any warranties, express or implied, as to its merchantability or fitness for a particular purpose. As a Participant, I agree to utilize all data received by the MLS in accordance with the MLS Rules and Regulations. Participant is hereby noticed that all data obtained from the MLS Computer System is federally copyrighted. Providing MLS information to unauthorized recipients may be a copyright violation. Any violation of said copyright will be prosecuted to the fullest extent of the law.

The Designated REALTOR®/Broker authorizes all Wyoming licensees in the office to have access to the MLS computer system through the office or their own personal computer equipment. I hereby authorize the MLS to work with any approved 3rd Party Vendor on my and my agent's behalf as agreed to in the Third-Party Access Agreement.

This Participation Agreement may be terminated upon written notice to the MLS and can be terminated by the MLS in accordance with NEWRA Bylaws and MLS Rules & Regulations. Upon termination, all active listings of agents will be transferred in the MLS computer system to the Designated REALTOR®/Broker. If the Designated REALTOR®/Broker terminates membership, all data obtained from the MLS must be immediately destroyed (except those records required to be kept by law) or holder of said data will be in violation of the federal copyright.

Due to the serious nature of this agreement, the Designated REALTOR®/Broker has agreed to review with each licensee in his/her office the potential consequences of a violation of the NAR Code of Ethics, NEWRA Bylaws and/or MLS Rules & Regulations, particularly as it relates to the unauthorized dissemination of MLS copyrighted information.
