MLS Only Participation does not convey Primary or Secondary membership in the Northeast Wyoming REALTOR® Alliance (NEWRA) nor does it grant the participant the benefits, certain services or protection of REALTOR® membership.

As an MLS Only Participant, you may be eligible for the following services ONLY:

- \checkmark Access to the FlexMLS System
- \checkmark Access to use the Sentrilock Lockbox/Keycard System
- \checkmark Advertise qualified active listings in the NEW Real Estate Magazine

You will NOT receive:

- ◎ Protection, benefits or certain services provided to members of the NEW REALTOR Alliance.
- \otimes Access to NEWRA provided free/reduced rate education.
- 𝛇 Access to real estate contracts provided to members of the Wyoming Association of REALTORS®.
- ◊ No eligibility to vote or hold office in either the NEWRA or NEWRA∼MLS Committee.

Requirements of MLS Only Participation: Please initial and return with packet.

- ____ Must hold a current, valid Wyoming Real Estate License or be certified in Wyoming to engage in the appraisal of real property.
- _____ Must be a primary member of a Board of REALTORS in the state of Wyoming or contiguous state.
- _____ Must hold primary MLS membership in a Board of REALTORS in the state of Wyoming or a contiguous state.
- _____ Designated REALTOR (Broker) must be an active NEWRA MLS Only Participant for additional agents to participate.
- All members holding a current, valid Wyoming Real Estate license or are certified by the WREC to appraise properties under the Designated REALTOR (Broker) are required to join as well.

Additional documentation required to accompany your MLS Only Participant application:

A letter of good standing from your primary REALTOR® Association and their MLS.

- A copy of your Wyoming real estate license or appraiser certification. Must be licensed/certified in Wyoming to receive services.
- MLS Participation Agreement, MLS Broker Membership Application & Agreement and the MLS Office Membership Application & Agreement.

Payment for all applicable fees (see price sheet). We accept checks, debit and credit cards.

I understand, the Designated REALTOR®/Broker, is responsible for all licensees in the office and the licensees that access the MLS system through participation. It is also understood that The Firm is jointly and severally liable for all service fees incurred by the Firm and/or by said licensees.

Participant and Firm agree to indemnify and hold the MLS harmless from all claims and liability relating to Participant and Firm's use of the MLS system and services.

As a Participant, I have read, understand, and agree to abide by the NAR Code of Ethics and the MLS Rules & Regulations. Additionally, I understand that the information obtained from MLS is confidential proprietary market information which is available only to Participants of the MLS. Designated REALTOR®/Broker is hereby noticed that all data obtained from the MLS Computer System is federally copyrighted. Providing MLS information to unauthorized recipients may be a copyright violation. Any violation of said copyright will be prosecuted to the fullest extent of the law.

I understand that as/the Designated REALTOR®/Broker, authorizes all Wyoming licensees in the office mention above to have access to the MLS computer system through the office or their own personal computer equipment. I understand that agents licensed in the office that have signed the MLS Waiver may not in any way have access to or use of the MLS System or any services provided by NEWRA~MLS and further understand that by allowing access to unauthorized agents could result in fines and loss of privileges.
